Bidders submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified above till 13th Feb 2020 during office hours. and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Also submission of signed Letter of Bid, along with the copy of company/firm registration, Business registration and renew certificate, tax clearance certificate up to FY 2075/076 and time extension in case of previous FY clearance is compulsory.

4. Pre-bid meeting shall be held at Office of Executive Rural Municipality, Sarawal Rural Municipality Sarawal, Nawalparasi at 14:00 hrs on 22nd day from the date of published.
5. Sealed or electronic bids must be submitted to the office Executive Rural Municipality, Sarawal Rural Municipality Sarawal, Nawalparasi by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 hrs on 14th Feb 2020. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 14th Feb 2020 at the office of Office of Executive Rural Municipality, Sarawal Rural Municipality Sarawal, Nawalparasi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum as mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
